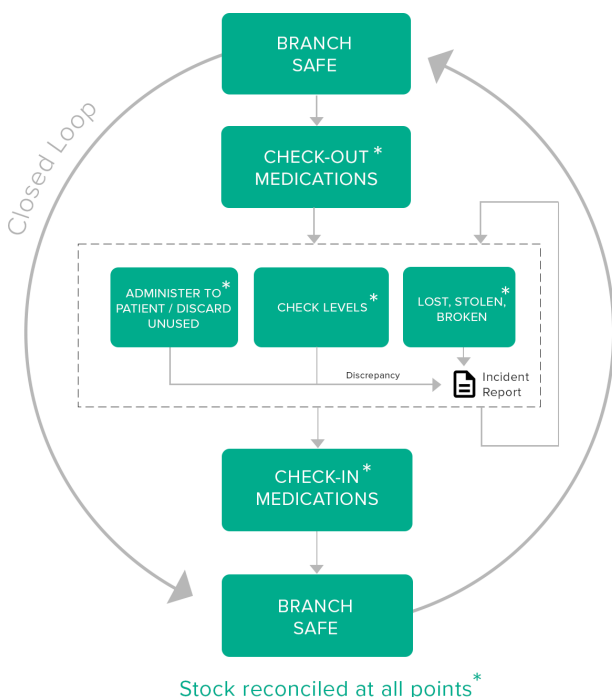
CDM provides a comprehensive suite of automated processes, functions and integrations to seamlessly manage and report on medication related distribution and administrative activities.

Paramedic Workflow



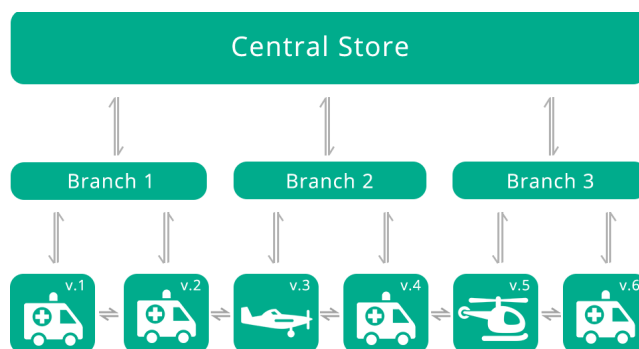
Features for Administrators and Managers:
