## UK Ambulance Service NHS Trust selects HealthCare Software's Controlled Drugs Management solution – becomes first UK Customer

CDM provides a digital solution to replace paper CD registers, giving Clinicians confidence that they are meeting their legislative obligations, Managers an instant view of all CD-related transactions in their area of responsibility and Supply and Pharmacy transparency over the use of CDs across the service.

The Chief Pharmacist and Clinical Director of Medicines at the Service said, "HCS' CDM solution will transform our management of Controlled Drugs. Their solution is exclusively built for ambulance services making it highly suited to our dynamic work environment while hugely increasing our visibility of CD transactions by replacing paper registers with their digital solution.
